If a student decides to *withdraw* from the course, they have until Friday, July 24, 2020; no refund will be given and the student receives a "W" on their Drury transcript. *Payment of the course/s is still due to the Business Office*. Any withdraws after the withdraw date will result in the student receiving the grade earned for their course/s.

Now that we have moved to the online application and registration process, these deadlines align with the Academic Calendar on Drury's website and **cannot be modified, except for finals and the end date of online courses – these dates have been moved up one (1) week**. Please communicate this with your DC teachers, DC students, and their families the importance of adhering to these dates. If a student decides to **withdraw** from a course, they have until **Friday, April 16, 2021**; no refund will be given and the student receives a "W" on their Drury transcript. *Payment of the course/s is still due to the Business Office.* Any withdraws after the withdraw date will result in the student receiving the grade earned for their course/s. **DC ONLINE GRADES ARE DUE Monday May 17, 2021; however, you may have some students that need their grades sooner because of graduation dates. Please check with your class in January and find out who the seniors are & when they need their final grades.**
