Transfer herbarium specimens on acid free paper.
Make copies of existing labels and attach it to the new herbarium paper.

1. 90 %	As Needed	Transfer plant specimens to acid free paper, make copies of label and glue them on the new paper, while ensuring accuracy of the transferred specimens, and specimens' preservation.
2. 10 %	As Needed	Assist with various tasks for the Biology department.

1. Must be very patient as some herbarium specimens are old and frail.
2. Must be able to perform work that requires high attention to detail, and ensure accuracy.
3. Dependable, honest, and have a sincere interest in assisting the Biology Department.
4. Must be a regular, full-time day school student, enrolled in at least 12 hours per semester.
5. Must have completed a FAFSA form (Financial Aid) for the current academic year.

WORK CONDITIONS:

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job.
